COURSE OVERVIEW

This two-day interactive program is open to Supervisors and Officers conducting Background Investigations. The course is designed by Chief Bendul specifically for New Jersey law enforcement agency Background Investigators to increase their knowledge and obligations in managing the Pre-Employment Hiring Functions.

The course will breakdown New Jersey and federal employment law and how to supervise the hiring function in an expeditious and efficient manner.

This program will provide an opportunity for attendees to gain the necessary knowledge base relative to this important function.

Topics to be covered include, but are not limited to:

- The importance of a pre-employment background investigation, negligent hiring
- What may or may not be asked during an investigation

ABOUT THE INSTRUCTOR
